4. Entrants will be deemed to have accepted these terms and conditions and agreed to be bound by them when entering this Promotion.
5. One entry per household. Entries sent in through agents or third parties will be disqualified. Late, incomplete or otherwise ineligible entries will be disqualified.
6. One winner will be selected at random by an independent person, from all correct and eligible entries received on or around 29 December 2014. The winners will be notified by phone and / or email by 7 January 2015 and will have 2 days (48 hours) from initial contact in order to claim their prize. If direct contact with the winner cannot be made within this 48 hour period or they are not able or available to accept the prize for any reason which is beyond the Promoter's reasonable control, then the Promoter reserves the right to award the prize to another entrant.

The Prize will be subject to the Prize Conditions (as defined below).

The winner will need Sky+HD professionally installed even if the winner already has a minidish. Costs may apply for non-standard set-up. The winner must keep their Sky+HD box connected to a fixed

and operational telephone line. If the winner needs a minidish the winner will be responsible for obtaining all consents required (e.g. landlord's) before installation.
